### SUMMARY ANNUAL REPORT FOR

# BAY AREA AUTOMOTIVE GROUP WELFARE FUND

This is a summary of the annual report of the Bay Area Automotive Group Welfare Fund, EIN 94-6072964, Plan No. 501, for year ended November 30, 2023. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The plan has committed itself to pay certain medical, dental, and prescription drug claims incurred under the terms of the plan.

### Insurance Information

The plan has contracts with Delta Dental of California, Kaiser Foundation Health Plan, Inc., Newport Dental Plan, Reliastar Life Insurance Company, The Prudential Insurance Company of America, UnitedHealthcare Insurance Company and Vision Service Plan to pay certain life insurance, accidental death and dismemberment, medical, dental, vision, and prescription drug claims incurred under the terms of the plan. The total premiums paid for the plan year ending November 30, 2023 were \$33,013,029.

### **Basic Financial Statement**

The value of plan assets, after subtracting liabilities of the plan, was \$28,672,634 as of November 30, 2023, compared to \$24,569,709 as of December 1, 2022. During the plan year the plan experienced an increase in its net assets of \$4,102,925. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$47,954,321, including employer contributions of \$45,497,152, employee contributions of \$263,228, realized losses of \$46,299 from the sale of assets, earnings from investments of \$840,392, and other income of \$1,399,848.

Plan expenses were \$43,851,396. These expenses included \$1,758,238 in administrative expenses, and \$42,093,158 in benefits paid to participants and beneficiaries.
