## **PLAN CHANGE NOTICE Summary of Material Modifications**

**TO ALL ACTIVE PLAN 17AA PARTICIPANTS, DEPENDENTS and COBRA PARTICIPANTS:**

### **KAISER MEDICAL BENEFIT CHANGES**

Effective December 1, 2025, the benefits provided under the Plan 17AA Kaiser medical option will change as follows:

- Office visit co-pays will increase from \$15.00 to \$20.00.
- Generic prescription drug co-pays will change from \$10.00 for a 100-day supply to \$10.00 for a 30-day supply and \$20.00 for a 100-day supply through mail order.
- Brand name prescription drug co-pays will increase from \$15.00 for a 100-day supply to \$20.00 for a 30-day supply and \$40.00 for a 100-day supply through mail order.

There are no other changes to the Kaiser medical Plan. If you are enrolled in the Self-Funded medical Plan, there are no changes to your medical plan.
